## M.O.W. SPORTS CLUB MEMBER'S RULES AND REGULATIONS

- 1. A member shall register or sign in his or her guest whom he/she shall be responsible for his her/their conduct while in the club.
- 2.A member shall maintain Discipline while in the club at all time

Discipline in this case may includes

- ➤ Proper dressing code.
- > Engaging in a fight shall lead to automatic expulsion from the club
- > No member shall incite or plan a strike with other members .
- > A member shall not reprimand or abuse other members or our staff. Any misconduct shall be reported to the manager in writing or verbally.
- > Immoral behavior shall not be allowed in the Club .
- > A member shall respect warning signs where provided.
- 3.A member shall sign his / her bills and Account book before leaving the Club.
- 4.A member shall keep his / her Account in credit to avoid embarrassment.
- 5.No overdrawn accounts shall be served.
- 6.A member shall renew his / her membership in time to avoid penalty of 20% or being locked out.
- 7.Membership shall expire on 31st Dec. every year and grace period of up to 31st march shall be given for payment.
- 8. The Club shall close strictly at 12.00 midnight.
- 9.A member shall display car stickers and produce membership cards on request.
- 10.Drugs consumption including smoking and chewing of khat (miraa) within the club promises is highly prohibited
- 11.Use of mobile phones is prohibited in the Bars and Administration Blocks.
- 12.A member shall take care of his / her valuables.
- 13. Children under the age of 14 shall not be allowed in the Club after 8.00pm.
- 14. Children should be accompanied by adult members and the members shall take full responsibility of any undisciplined cases of their children.
- 15.No alcoholic Drinks shall be served to School, College and University Students and Children under the age of 18 years.
- 16. Member's children over the age of 24 years old are to be registered as independent members on paying 1/2 rates on the current entrance fee, pay current subscription of the year and service deposit.
- 17. Any member who has been declared Bankrupt shall automatically cease to be a Club member.
- 18. The family of the Deceased who at the time of death was a full member shall be

allowed to continue with the membership upon clearing any outstanding debts.

- 19.No Drinks or Food shall be allowed from outside to the Club or selling other items.
- 20. TV/Radio and other entertainment appliances shall be operated by the barman /waiter on duty.
- 21. No services will be allowed in the parking area or in the Vehicles.
- 22.In case of any unpaid account, the Management Committee will take legal steps to recover the debt.
- 23. Money once paid shall not be refunded.
- 24. The Management Committee shall welcome Complaints and Compliments verbally or Written through the manager of the club.
- 25.A member willing to break his/her membership for more than one year for any reason shall notify the management by filling in the membership deferral form and thereafter inform the club on their return
- 26. Vehicles shall be parked at owner's risk.
- 27.No Dogs or other pets shall be allowed in the Club premises.
- 28. Parking on Reserved parking bays is prohibited.
- 29. Members shall help maintain tidiness in the compound by placing litter in the bins provided; relieving oneself and spitting in public places is highly prohibited
- 30. Speed limit in parking area 5kph
- 31. Riding, Driving or Parking on the Pitch and Jogging Track is prohibited
- 32.A member shall be responsible for damages or breakages of the club's property caused by him/her while in club.
- 33. The Club offers overnight parking for small vehicles at a fee,
- 34. Sports gear attire not allowed in the bars.
